# PLUMBING INSPECTOR

## APPLICATION FOR EXAMINATION AND LICENSING AS A PLUMBING INSPECTOR

### INSTRUCTIONS

1. An approved application on file with the Plumbing Section at the Department of Health means a person is approved to take the plumbing inspectors examination to be certified.
2. Individuals applying for plumbing inspector certification will not receive a licensing card until such time the applicant attends the required training school. Applicants must receive a confirmation letter insuring their application is on file before attending a training school. Failure to have an application on file will result in not being approved for training.
3. All applicants shall take and successfully pass an examination before receiving a plumbing inspector license and shall not be eligible to perform plumbing inspections.
4. Plumbing Inspectors that fail to receive training within the prescribed timeframes, shall be become suspended and be required to reinstate their licenses. A yellow reinstatement application is required for suspended licenses due to failure to attend recertification training. These may only be obtained and submitted at a Plumbing Inspector Training Program.
5. Section # 3
  - a. If you have never been certified as a plumbing inspector, indicate so by marking the "**NEW**" box.
  - b. If you are already certified for a water system for plumbing inspection and would like to add another system, indicate so by marking the "**ADDING**" box.
  - c. If you are dropping a system and would like to change to another system, indicate so by marking the "**CHANGING**" box.

Special consideration for Active Duty service members, returning veterans, and spouses is available for licensure, certification, or permitting per Ark. Code 17-1-106.
