#### III. COMMITTEE REPORTS

### A. FINANCE COMMITTEE

Janice Ivers, Chairperson for the Finance Committee, along with Darla Erickson, Administrative Services Manager, covered items for the Finance Committee. The following motions were presented:

**MOTION 4:** I move that the Arkansas State Board of Nursing approve the report reconciling the ASBN financial statements to the AASIS documents received by the Department of Finance and Administration- Service Bureau for the State Board of Nursing for the periods April 2019, May 2019, and June 2019. **PASSED.**

**MOTION 16:** I move that the Arkansas State Board of Nursing grant Prerequisite Approval to the Harding University Carr College of Nursing to establish two initial licensure Master's Entry into Professional Nursing (MEPN) program tracks. Admission will include either 90 completed undergraduate hours, or a BA or BS, along with required nursing prerequisite courses, and who meet all other eligibility requirements. **PASSED.** 

**MOTION 17:** I move that the Arkansas State Board of Nursing grant Initial Approval to Southern Arkansas University Tech LPN/Paramedic to RN Associate of Applied Science in nursing program to begin admission in June 2020. **PASSED.** 

Tammy Vaughn informed the Board six (6) nursing educational programs obtained 100% NCLEX® pass rates this year and the three (3) programs fell below the 75% pass rate. Ms. Vaughn further advised the Board that the University of AR – Monticello College of Technology in McGehee obtained six (6) consecutive years of 100% pass rates, Phillips Community College UA- Dewitt- PN obtained five (5) consecutive years of 100% pass rates, and Arkansas Northeastern College- Blytheville obtained three (3) consecutive years of 100% pass rates.

The Education Committee approved their minutes from the May 9, 2019 meeting and reviewed their strategic plan.

### C. PRACTICE COMMITTEE

Lance Lindow, Chairperson for the Practice Committee, and Mary Trentham, Attorney Specialist, covered items for the Practice Committee presented the following motion on behalf of the Practice Committee.

**MOTION 18:** I move that the Board direct staff to develop a position statement regarding Registered Nurse-Driven Standing Orders as recommended by the Institute of Medicine's (renamed the National Academy of Medicine) vision of team-based diagnosis supported by the Center for Medicare and Medicaid Services Revisions for Hospital Conditions of Participation per §482.24(c)(3)(77 FR 29002 & 77 FR 29034). **PASSED.** 

Strategic Initiative III, Objective 2 cannot be met at this time. CORE data collection by NCSBN has been suspended and the need for collection for it will be reviewed by NCSBN in 2020.

The Practice Committee approved their minutes from the May 9, 2019 meeting, discussed open disciplinary cases and reviewed their strategic plan.

**MOTION 24:** I move that the Arkansas State Board of Nursing allow ArNAP participant AH3587 to continue their present employment in the Emergency Department with a worksite monitor, and to be allowed to continue taking the following long-term abuse potential medications for their medical conditions while enrolled in ArNAP: Flexeril 10mg BID.

Debbie Rodgers discussed details regarding her doctorate program and her study of drug diversion in nursing homes. Ms. Rodgers will pair with Pao-Feng Tsai, RN, PhD to

investigate details of cases for the year 2018 filed at the Arkansas State Board of Nursing and include the following data from the chart reviews: demographics, nursing credentials, previous disciplinary action by a Board of Nursing, type of facility where diversion occurred, and type of complaint received. Information gathered will not contain identifiable information that could be linked to participants or patients. This study will compare diversion rates between hospitals and nursing homes.
